

Adding value to bill printing technology




A view of the state-of-the-art technology at the Head Office


SGC has the leading edge in generating informative and easily legible monthly utility bills for its customers. The Company's IT Department ensures the quality of bill generation and door to door delivery by underpinning contracts with reputed suppliers. Around 2.7 million bills are generated and distributed through dispatch service every month.

In the past, the bill generation contract was outsourced to IBM Pakistan. The prolific contract with IBM concluded in February 2016. One of the IT Department's main goals now was to introduce "cost-efficiency" in the new bill printing contract. The challenge was to find a way to produce utility bills in a cost-effective way, without compromising on the quality of service.

Following the process of procurement, the IT finalized a cost-effective service provider (GEMCO Pakistan) that agreed to offer additional value-adding services that were not part of the previous contract. GEMCO Pakistan has been on board since February this year and has so far delivered required services quite well.

New and upcoming value added services:

Recovery site, in case if the Billing Center is impacted due to any incident. IT successfully tested this arrangement during service transition from IBM to GEMCO in February 2016.

- IT has plans to implement e-Bill (a green initiative) via email/SMS to all franchise customers by June 2016.
- IT had ensured that skilled and industry certified staff is involved in bill printing service delivery.
- Use of latest state-of-the-art RICOH high-end printers, duly supported by GEMCO's Karachi office.
- Additional required safety measures were implemented by introducing environment protective packaging material, so that the bills reach our customers in the same condition as they are being printed and are protected from environmental factors.

onorable Minister of State for Petroleum and Natural Resources Jam Kamal Khan, visited SSGC head office on March 25, 2016. The Minister of State (MoS) chaired a meeting in which Project Director Asim Tirmizi gave him a detailed presentation on the ongoing pipeline projects that are currently underway.

MoS asked various question regarding the progress of these projects and their respective timelines. PD then gave a presentation on the LPG Air Mix plants to the MoS. AGM (CCD) Shahbaz Islam also

gave a presentation to the Minister on Corporate Social Responsibility (CSR) and informed at length, the initiatives taken by SSGC in Sindh and Balochistan to facilitate the communities.

MoS advised SSGC to expand its network of Bio-gas plants to various other places especially to the remote areas as they are of extreme benefit for the marginalized communities. He further advised to look into the possibilities of arranging skilled training for the young people of Gwadar.

Concluding the meeting the honourable

Minister advised SSGC for sending two to three people abroad for acquiring training on the developments on automatic pipeline welding.

Later the MoS addressed a sizeable group of media persons in the auditorium, briefed them on the steps taken by the Government to reduce the demand and supply gap of natural gas and spoke about the progress on other government's initiatives in the energy sector. He also replied to a number of questions raised by the journalists.



















Task Force cracks down on a prominent restaurant





SGC's Task Force conducted a raid at a prominent restaurant located at junction of Karsaz and Shahrah-e-Faisal on March 15, 2016 and disconnected gas supply which was being used illegally from the main SSGC distribution lines through G.I pipes. It must be noted that recently the gas supply to the restaurant was disconnected due to illegal commercial gas usage on account of a residential gas meter, but despite the disconnection the perpetrators re-connected the supply line, through illegal means.

According to an estimate, gas amounting to Rs. 500,000/- per month was being illegally consumed to run a 27 KVA gas generator, 10 gas burners and 1 gas geyser. Police force also arrested an employee of the restaurant and lodged a FIR as per Pakistan Penal Code section 462-AH. O









SSGC undertakes raid in Hub City Illegal gas supply to more than 200 houses suspended and two hotel owners arrested

n continuation of its efforts in overcoming the UFG (Un-accounted for gas) and nabbing the gas thieves, SSGC's concerned departments made another big crack down on Culprits in Hub City. The officials of Surveillance and Monitoring Department conducted the raid. The FIA officers who arrived from Quetta also participated in the operation for providing legal cover to SSGC's contingent.

The raids were conducted at Al-Usmania Hotel situated in Allah Abad Town, Main RCD Highway, where the owners were illegally getting gas, directly from SSGC's main distribution pipeline at 6 pound per square inch (PSI) pressure, which was being used to operate one Tandoor, 18 burners having 52 nozzles and one 5 KVA generator. According to a quick estimate, made on the spot, a quantum of 1,525 cubic feet gas per hour was being stolen to use in the appliances, which amounts to Rs. 5,039,820 per annum. SSGC already has a claim of Rs. 4,263,700 on this hotel for non-payments of

The joint team consisting of officers and staff of Distribution and Maintenance Departments, members of FIR Cell of Customers Services Department and FIA conducted another big raid at Gul Khuzdar Hotel (known as Daru Hotel), Hub during the same evening, where the owners were also stealing about 465 cubic feet gas per hour through an illegal connection taken from SSGC's Pressure Reducing System

(PRS) main distribution line having a pressure of 6 psi to operate one big Tandoor and 8 heavy burners having 26 nozzles. According to an estimate, the hotel owners were stealing gas worth Rs. 1,536,732

In Hub City, SSGC Team also disconnected more than 200 domestic illegal connections on account of using un-metered gas, which was being obtained through an illegal network that was managed by culprits of

HSE&QA management

PPE Policy all set for enforcement



SGC's senior management recently approved HSE&QA Department's Personal Protective Equipment (PPE) Policy. The purpose of this policy is to provide guidelines for the identification, procurement, implementation maintenance of personal protective equipment. The policy applies to all employees and all Departments including Distribution and Transmission and all Locations including Head offices, Regional Headquarters, Offices. Compressor Stations, CFCs or any other facility which is directly run/operated by SSGC. The policy also applies to project sites managed by SSGC or outsourced through Contractors.

Personal protective equipment (PPE) is defined as equipment or devices worn or used to control exposure to hazardous substances or conditions or to prevent accidental injuries or serious harm to employees working in hazardous or potentially hazardous conditions or areas.

Responsibilities

HSE&QA will ensure the provision of adequate budget for PPE for regular operations, provide technical assistance in identifying potential hazards, PPE selection and sharing any information on regulatory compliance. It will also provide training and awareness on importance of PPE to SSGCL Employees.

The Departmental heads, on the other hand, will identify the needs of PPE according to the operations in their respective areas. They are also responsible

to positively implement this policy within their scope of work.

Employees will be expected to comply with this policy, and use appropriate PPE required to ensure safety. Employees are responsible to report any accidents or job related injuries. All Employees including site supervisors and HSE&QA representatives are authorized to stop the work in case work is carried out in hazardous manner without use of PPE.

EPA Holds public hearing on SSGC's RLNG project



n March 03, 2016, a public hearing meeting was arranged by the Sindh Environmental Protection Agency (SEPA), Government of Sindh. The main agenda was to discuss the report submitted by SSGC on environmental effects, (EIA) of the 42' dia, 338 km RLNG pipeline project being laid down from Karachi to Nara. The hearing was held at regional office Qasimabad, Hyderabad.

This public hearing meeting was presided by Muhammad Imran Sabir, Dy. Director Technical, SEPA. On behalf of SSGC, Wagar Ali, Dy. General Manager (LNG) provided details and awareness about the importance and significance of the project. an Environmental Expert Consultant also gave a presentation regarding Environmental Impact Assessment (EIA) report on SSGC's RLNG pipeline project.

Professor Khalida Faryal Aalmani, Director Environmental Sciences Sindh University, Shakila Laghari, Sociologist (SIDA), Munir Ahmed Abbasi, Regional Head (SEPA) Hyderabad, Aamir Mumtaz Khan, Acting Senior General Manager (General Services), Nisar Shaikh, Acting Senior General Manager, (Distribution North), Adnan Sagheer, Acting General Manager (Transmission) and officials of other departments and public representatives also attended this hearing.

SSGC team of expert engineers from different departments also answered the general public queries about the environmental effect of this project. A vote of thanks from Dy. Director Technical (SEPA) to the attendants, concluded the event.











LG Department – At the forefront of facilitating LNG imports




urrently, Pakistan is faced with an acute shortage of natural gas. The country's constrained demand for gas has reached 6 BCFD whereas the total production hovers around 4 BCFD. This widening gap between supply and demand of energy has posed a grave threat to the accelerated growth of the country and is estimated to cost approximately two per cent of GDP annually.

To overcome the shortage of natural gas, the Government of Pakistan has chalked out various energy mix options. Of these, bringing LNG to the shores of Pakistan has finally materialized. By virtue of the efforts of SSGC's Liquefied Gases (LGs)

Department, services for storage and re-gasification of LNG were procured from Engro Elengy Terminal (Pvt) Ltd. The Terminal was developed in a record time of eleven months and was successfully commissioned on March 28, 2015.

To date, SSGC gas received 30 cargoes of LNG at EETPL's Floating Storage Regasification Unit (FSRU) containing approximately 906 MMBtu of RLNG has been injected into the Company's high transmission network and an equivalent content of indigenous gas of the same volume (94,000 MMCF) has been swapped with SNGPL from various gas fields.

As one of the key stakeholders in the LNG project, the Company, during the year under review, embarked on developing an ambitious infrastructure for transmitting re-gasified LNG to the consumers. The Company's scope of responsibility includes receiving re-gasified LNG and transporting the same to its customers and SNGPL network through a dedicated pipeline that it is constructing. Work is fast progressing on the proposed 42" dia, 342-km pipeline for transporting 1.2 billion cubic feet (bcf) capacity from Karachi to the SNGPL network in Sawan. During the year, significant progress was made on RLNG project, which is expected to commissioned by December 2016. •





Check your Gas Lines for Leakages.

Regular check-ups minimise the dangers of gas leaks and help manage your gas bill. The following are 2 simple ways you can check for leakages in your home:

Home Appliances Test: Shut off all home gas appliances at night and note the meter reading. Next morning read the meter again before switching on any appliances. A change in figures would determine the leakage.

Soap Test: Make a solution of soap and water and apply to all gas pipes in your premises. In case of leakage the soap solution will produce bubbles at point of leakage.



& Caution: Do not check by using matches as this can be highly dangerous!


In order to acquire the proper saplings for plantation, HSEQA department established

World Energy Outlook 2016 and onwards (Fact Sheet)


igns of change in global energy have multiplied in the last 12 months. Oil prices fell sharply, with the prices of other fuels moving in tandem in many parts of the world. Countries including India and Indonesia took advantage of the oil price decline to move ahead with their phase-out of fossil-fuel subsidies.

Amid turmoil in parts of the Middle East, a clear pathway opened up that could lead to the return of Iran, one of the world's largest hydrocarbon resource-holders, to oil

markets. China's role in driving global trends is changing as it enters a much less energy-intensive phase in its development. Renewables contributed almost half of the world's new power generation capacity in 2015. The coverage of mandatory energy efficiency regulation worldwide expanded to more than a quarter of global consumption. There was also a tantalizing hint in the 2014-15 data of a de-coupling in the relationship between CO2 emissions and economic activity, until now a very predictable link.

As countries prepare for the critically important UN climate summit in Paris (also known as COP21) and its legacy, it is more important than ever for policy-makers, industry and other stakeholders to have a clear understanding of the state of the energy sector today, to see which changes are transient or cyclical, which are here to stay, what risks and opportunities might lie ahead – and what can be done to put the energy system on a more secure and sustainable footing.

China re-tunes the engine of global energy demand







hina's transition to a less energy-intensive model for growth has major implications for global trends. China carries huge weight in the world of energy: it remains by a distance the world's largest producer and consumer of coal throughout our Outlook period.

China deploys more renewable power generation capacity than any other country; and by the 2030s it is expected to overtake the United States as the biggest consumer of oil and will have a larger gas market than the European Union.

China's total energy demand in 2040 is expected to double that of the United States. But structural shifts in the economy, favoring expansion of the services sector rather than heavy industry (both steel and cement production are likely to have peaked in 2014), mean that 85% less energy is required to generate each unit of future economic growth than was the case in the past 25 years. Policy choices also change the face of China's energy system and the

pace at which it expands.

China is set to introduce an emissions trading scheme in 2017 covering the power sector and heavy industry, helping to curb the appetite for coal. From a mere 3% in 2005, half of China's energy use today is already subject to mandatory efficiency standards, and continued improvements in efficiency, alongside large-scale deployment of wind, solar, hydro and nuclear power, lead to a flattening and then a peak in China's CO2 emissions by 2030.

India seizes the centre of the world energy stage

ndia today is home to one-sixth of the world's population and its third-largest economy, but accounts for only 6% of global energy use and one in five of the population – 240 million people – still lacks access to electricity. With policies in place to accelerate the country's modernization and develop its manufacturing base (via the "Make in India" programme), population and incomes on the rise and an additional 315 million

people anticipated to live in India's cities in the next 2 decades, India is entering a sustained period of rapid growth in energy consumption.

Demand for coal in power generation and industry surges, increasing the share of coal to almost half of the energy mix and making India by a distance the largest source of growth in global coal use. India's oil demand is increasing than in any other

country, approaching 10 mb/d by the end of the period. India is also stepping up its deployment of low-carbon technologies, although uncertainty over the pace at which new large dams or nuclear plants can be built means strong reliance on solar and wind power (areas where India has high potential and equally high ambition) to deliver on its pledge to have a 40% share of non-fossil fuel capacity in the power sector by 2030.
