The work and materials shall be to the satisfaction of the Company's Engineer / Manager and the contractor's rates shall be include for all incidental and contingent work which, although not specifically mentioned in this agreement, a/re necessary for its completion in a sound and workman like manner.

The Contractor hereby agrees to indemnify the Company against all actions, suits, proceedings, claims, damages or expenses arising out of or in connection with the carrying out of the Work aforesaid whether or not such actions, suits, proceedings, claims, damages or expenses shall arise or be brought or have to be paid under the WORKMEN COMPENSATION ACT or otherwise. The Contractor also warrants that in performance of his obligations, he shall comply fully with the relevant laws of Pakistan.


