

## **PUBLIC ANNOUNCEMENT**

The Government of Pakistan has lifted ban on new domestic connections on RLNG based on OGRA determined and notified monthly RLNG tariff for distribution network. Applicants desirous of domestic connection on RLNG may submit their applications with Sales Department, Head Office near Civic Center, Gulshan e Iqbal Karachi/ Customer Facilitation Centers (CFCs) / SSGC Web & App. Applicants other than Karachi may submit their applications with their respective SSGC Regional / Zonal Offices.

Galvanized pipe ½ inch diameter shall be formed in accordance with the requirement of BS 1387 medium grade (Latest Edition). Pipe and shall be supplied with treaded end conforming to BS-21 taper pipe tread.

Only Metallic Pipes (G1 Pipes OGRA Specifications) are allowed. Installation of Gas Pipelines in solid wall / partitions in not allowed. No gas pipe shall be installed underground in concrete / cement floors.
